

CREDIT UNIONS' UNCLAIMED BALANCES

The Credit Union Deposit Guarantee Corporation (the Corporation) receives unclaimed balances from Alberta Credit Unions. The unclaimed balances are customer accounts transferred to the Corporation from credit unions after 10 years of inactivity. In accordance with the Credit Union Act, the Corporation holds these balances for a further 20 years. If no valid claim has been made, the balance is transferred to the Government of Alberta's General Revenue Fund. After that transfer, the person(s) can no longer make a claim. Below is the listing of persons or companies, located or formerly located in Alberta, that have unclaimed balances that the Corporation has held for 20 years which are planned to be transferred to the Government by December 31, 2022.
